# Note on Title Change: TSI/ATSI

After a more thorough review of the US ED ESSA plan and the AK State ESSA plan it was determined that we have been misusing the term ATSI.



Per the AK ESSA plan, TSI and ATSI are the SAME STATUS.

# WHAT DOES THIS MEAN?

- ATSI status = TSI status as previously understood
  - Annually designated
  - \$25,000 1003(a) grant
  - Follow the Empowerment Process and make a 3-year plan when designated



# Note on Title Change:

The nitty-gritty of it is, when Alaska was creating its state plan, following guidance from US ED, it essentially bypassed the category of TSI, which would have created many more designations, and made the Targeted Support threshold match the lowest 5%, which fell into the Additional Targeted Support and Improvement category, wrapping two categories into one.

It's confusing NOW, but in 2 years we'll have forgotten this ever happened.

Moving forward, TSI/ATSI schools will just be called .... ATSI.

- 2023 (\$25,000 FY24)
- Implementation process to be reviewed and updated as needed
- Index scores from 22/23 data available in late April due to standard setting validation to confirm/refine the cut scores established in 2022
- Designations determined:
  - ATSI schools from 2022 may exit if they show growth and surpass the ATSI performance threshold (5%)
  - Schools at or below the ATSI performance threshold will be designated ATSI for SY 24/25
    - If already designated, continue implementation into SY24/25
    - If newly designated, needs assessment/planning will not happen until SY24/25


