Mt. Edgecumbe Administration recommends Travis Vaughan for the Sitka Community Representative. The incumbent for the position is Lois Rhodes, who has chosen to not seek continued appointment. Lois Rhodes served on the board for over 20 years.

Travis Vaughan- Recommended

Jerilyn thinks that what makes her uniquely qualified for the Parent Representative position is that she has become acquainted with her local Associated Student Body policies and procedures. She is gaining knowledge about the district board policies and strives to learn more about how other schools and districts operate so that she can have a perspective on how to help enhance the education system.

Charlene Robinson
